Specification, overview and lot structure

Framework agreement

In addition to offering competitive pricing, suppliers/providers were required to demonstrate their capabilities of delivering the requirements of this framework by answering a series of questions relating to quality, sustainability, delivery and customer service.

The award criteria/weightings used to establish this framework are detailed below:

Quality and Sustainability	30%
Delivery and Customer Service	30%

Term and conditions

Suppliers/providers awarded to the framework agreement have agreed to and signed YPO's standard Terms and Conditions. These can be amended by the CA and supplier/provider by mutual agreement to include additional terms to supplement the standard Terms and Conditions.
